Return to Learn

Mr. Voehringer reported that our school nurse, Annie Byrne was recognized by other Superintendents in the Township as being a leader in getting information out to other districts.

The vaccination phase 1A includes medical personnel. School nurses, speech therapists, social workers, and psychologists are also included in Phase 1A. Phase 1B includes all school employees. An email was sent to staff today to fill out a

survey to be scheduled to be vaccinated. After filling out the survey, employees will be contacted by the Cook County Department of Public Health as to when they can receive their vaccine. Cook County estimates phase 1B vaccinations to take place in February or March. Mr. Voehringer stated that if employees live in areas such as Skokie or counties other than Cook, it might be faster to get the vaccination where they live.

Friday, January 15th is a Teacher Institute Day. Teachers will attend in person. Monday, January 18th is Martin Luther King Day and is a school holiday. Students who elected in-person learning will return to school on Tuesday, January 19th.


Mr. Condon sent out an email today to the parents of in-person learning students which outlined expectations. The students will still attend from 8:20am to 12:20pm. This schedule will continue until Illinois goes into Phase 5. At that point the district will go back to full day in-person learning for all.

Morton Grove's positivity numbers have remained about the same as last week, which was 5.92% which is lower than it was in October and November, but still in the orange.

There will not be a Committee of the Whole meeting next Monday due to the holiday but there will be a regular board meeting on Wednesday, January 20th.
